

Filling out a Nevada title

Before the boxes make sense, it helps to see which part of the page they are on. A Nevada title has four regions on the front and only one is yours. The back is dealer territory - if someone tells you to sign it, they are thinking of another state.

ALTERATION OR ERASURE VOIDS THIS TITLE

Back. Two dealer reassignment blocks and a box for the buyer's lender.

Four ways to ruin it. Any alteration or erasure voids a Nevada Certificate of Title. There is no correction fluid, no scribbling out, no writing over. Get it wrong and you are applying for a duplicate. A Social Security number never goes in the ID field. The odometer reading excludes tenths. And names with nothing printed between them count as AND, so everyone signs.

Filling out a Nevada title

Transfer section of a VP-2 (Rev 2021) Nevada Certificate of Title, filled in with sample values. Field numbers match the Nevada DMV Registration and Title Guide, revised April 2025. Green rows are the ones you complete as the seller.

17	LENDER	Lienholder release	This is not yours to fill in. If the box is filled and the car is paid off, you are clear to sell.
18	BUYER	Printed full legal name and address of buyer	Trading as a business? Put DBA in front of the business name. Leased? The words Lessee and Lessor go after the full legal name, and multiple lessees are separated with a semicolon.
19	BUYER	Nevada driver's license, ID number or FEIN	No Nevada license or ID? Print "No Nevada DL or ID". A business with no FEIN? Print "No FEIN". Never write a Social Security number here.
20	BUYER	The AND / OR box	One tick, and it decides how hard the buyer's own future sale is. Most people want OR and never think about it.
21	YOU	Odometer reading	Not the rounded number, not last month's number. Walk out and read it.
22	YOU	Odometer declaration	The exemption line is where people go wrong. A 2021-issue title says over 20 years old; a title printed under the old rule says over 9 years. The 20-year rule is the one in force.
23	YOU	Signature and printed name of seller	Exactly as printed. Not your married name if the title has your maiden name, not initials if it spells you out.
24	DEALER	Dealer license number	Blank is correct for a private sale.
25	YOU	Date of sale	This date starts the buyer's 30-day clock to register, and it is the date your resale notification should match.
26	BUYER	Signature and printed name of buyer	Do not let them take the title away to sign it later. Unsigned here, the transfer is incomplete.

The same thing, bigger

The transfer section runs the full width of the title, which makes it small on a page. Here it is cut down the middle of the form — the left-hand column first, then the right-hand column of the same rows.
