

How to fill out MVD-10022 — Affidavit of Non-Receipt

New Mexico · written against MVD-10022 (Rev 12/90), issued under Vehicle Procedures Manual, Chapter 8
Section O (Re-Issuance of Title after Non-Receipt)

For the document that never came. Three checkboxes name what went missing - a registration with sticker, a cab card with sticker, or the Certificate of Title - and the affidavit certifies that you applied and paid for the item, did not receive it, and still live at the address it was sent to. Where the division mailed a title to a wrong address through its own clerical error, the manual pairs this affidavit with a no-fee replacement; where the address was right and the mail simply failed, the duplicate-title route and its fee take over.

This sheet is not the form. Download the blank MVD-10022 from the New Mexico Taxation and Revenue Department, Motor Vehicle Division at <https://realfile.tax.newmexico.gov/mvd10022.pdf> — always take the current revision from the agency rather than a copy. Print this and keep it beside you while you complete theirs.

Every line, in the order you meet it

1	YOU	Check one box	Registration with sticker, cab card with sticker, or certificate of title - whichever never arrived. Watch out: For a private seller or buyer the third box is almost always the one; cab cards belong to commercial fleets.
2	YOU	The vehicle and registration period	Year, make, model, body type, VIN, plate, and the registration year or month/year involved. Watch out: The sticker-period field only matters for the two sticker options - a missing title needs the vehicle identified, not a validation period.
3	YOU	How you paid	One payment box, and for a check, copies of both sides of the cancelled check attached. Watch out: The affidavit's strength is that payment can be verified. Dig out the bank record before the counter visit, not after the clerk asks.
4	YOU	Read the certification, then sign	You are certifying three things at once: you applied and paid, you did not receive, and your address has not changed. Watch out: That third clause is the trap. If you moved between applying and swearing, stop - file the address change and take the duplicate route instead of certifying something false.
5	YOU	File it where the record lives	At a field office with your licence, or by mail with a photocopy of it. Watch out: If the division's own error misdirected the title - wrong address by clerk mistake, inside the manual's 30-and-90-day windows - the replacement is free. Say so plainly; the clerk can see the mailing history.

What gets this one rejected

- More than one box checked. The affidavit covers the item indicated - one affidavit, one missing document.
- An address that has changed. The certification's last clause is that your address has not changed; if it has, this affidavit is the wrong instrument and the address change comes first.
- No proof of payment behind a check claim. The form asks for the cancelled check, both sides - the affidavit certifies you paid, and the copy is what makes that checkable.
- Filed for a title the record shows was never issued. Non-receipt presumes the division sent something; a title never applied for is a transfer, not a replacement.
- Used outside its windows for the no-fee route. The manual's free reissue requires at least 30 days since issuance and a request within 90 days of it - outside those, the ordinary duplicate fee applies.
- Sworn loosely. Like every New Mexico motor-vehicle affidavit, a false statement here sits under the fourth-degree-felony perjury statutes.
