

How to fill out MVD-10705 — Request for Vehicle or Hull Identification Number Verification

The letter New Mexico writes to another state when a vehicle's numbers and its paperwork disagree. Addressed ATTENTION: MOTOR VEHICLE ADMINISTRATOR, it asks the titling state to check its records - most often because a New Mexico VIN inspection read one number off the metal while the out-of-state title says another - and to issue a corrected ownership document or a letter indicating the correct identification number. Two further checkboxes serve lien and bond notifications, and page two is a directory of every state's motor-vehicle agency with mailing addresses, phone and fax numbers and each state's record fee.

This sheet is not the form. Download the blank MVD-10705 from the New Mexico Taxation and Revenue Department, Motor Vehicle Division at <https://realfile.tax.newmexico.gov/mvd10705.pdf> — always take the current revision from the agency rather than a copy. Print this and keep it beside you while you complete theirs.

Every line, in the order you meet it

1	YOU	Name the state	The STATE OF line, matching the title's state of issue, with the agency's address copied from the page-two listing. Watch out: Use the directory's own entry even if you know a newer address - the fee column beside it is the other half of what you need.
2	YOU	The vehicle and its title number	Year, make, model and the out-of-state title number - the record you are asking them to check. Watch out: The title number matters more than usual here: the VIN is the thing in doubt, so the title number is how their clerk finds the file.
3	YOU	The two disagreeing numbers	Tick the first checkbox and complete both lines: the VIN or HIN the visual inspection revealed, and the one the certificate indicates. Watch out: Copy the inspection reading from the inspector's completed form, not from your own look at the dash - the certified reading is the one the division will act on.
4	YOU	The return block, and the envelope	Your name, address and telephone in the return block, with a self-addressed stamped envelope and the listed fee enclosed. Watch out: The NM-PRC line is for licensed professionals; a private individual leaves it empty. What you cannot leave out is the fee - check the directory's column for the state you are writing to.
5	YOU	Wait, then transfer on the corrected paper	The state replies with a corrected ownership document or a letter stating the correct number; the New Mexico transfer proceeds on that. Watch out: Warn your buyer about the timeline honestly. The 30-day transfer clock is theirs, and a sale signed before the correction returns puts their deadline against another state's mailroom.

What gets this one rejected

- Sent without the other state's fee. The directory on page two lists what each state charges for a record search, and a request without its fee comes back unanswered.
- Both VIN lines filled with the same number. The first checkbox exists to document a discrepancy - inspection says one thing, title says another - and identical numbers state no problem to solve.
- Used to repair a New Mexico title's error. A wrong VIN on a New Mexico document is the Affidavit of Correction's territory; this request interrogates another state's record.
- No self-addressed stamped envelope on an out-of-state request, which the form itself asks for.
- The wrong checkbox for the job. The bond and lien options serve specific statutory processes with their own notification duties - a title-and-registration mismatch is the first box, alone.
- Expecting it to move title. The reply corrects a record; the transfer still runs on the corrected document once it arrives.
